IMPORTANT INFORMATION

- **Check-in Time** : Passenger to report 2 hours before departure. Check-in procedure and baggage drop will close 1 hour before departure.

- **A Note on Guidelines** : Please note that travellers are solely responsible for ensuring their eligibility to enter the destination or transit countries. We accept no liability in this regard. Please check the travel rules of all regulatory websites before booking and commencing travel.
- **Please Note** : Wearing masks/face covers is no longer mandatory. However, all travellers are advised to wear them, in view of the threat posed by COVID-19.
- **Travellers arriving in India must follow these guidelines** : Who can travel? Only asymptomatic travellers will be allowed to board after thermal screening. All travellers are advised to be fully vaccinated. Test on Arrival: A sub-section (2% of the total passengers* in all incoming international flights) shall undergo random post arrival testing at the airport. Registration Requirements: Pre-departure COVID-19 testing and uploading Self-Health Declaration on Ministry of Civil Aviation's 'Air Suvidha' portal will no longer be required for international travellers coming from/via China, Singapore, Hong Kong, Republic of Korea, Thailand and Japan, from 13th Feb 2023, 11 a.m. However, the exercise of random testing of 2% travellers to India (irrespective of country of origin) upon arrival in India shall continue. Quarantine Requirements: The samples of travellers testing positive, will be further sent for genomic testing at INSACOG laboratory network. They shall be treated/isolated as per the standard protocol. COVID Guidelines and Vaccination Requirements: - All travellers should preferably be fully vaccinated. - In-flight announcement about the ongoing COVID-19 pandemic including precautionary measures to be followed (preferable use of masks and following physical distancing) shall be made in flights/travel and at all points of entry. - The travellers with COVID-19 symptoms shall be isolated as per the standard protocol i.e. the traveller should be wearing a mask and he/she will be segregated from other passengers and isolated for follow up treatment. - De-boarding should be done ensuring physical distancing. - Thermal screening would be carried out for all the travellers. The travellers found to be symptomatic during screening shall be immediately isolated and taken to their nearest health facility as per health protocol. - After arrival, all travellers should self-monitor their health and report to their nearest health facility or call National Helpline Number (1075)/State Helpline Number if they have any symptoms. Important: Pre-departure COVID-19 testing and uploading Self-Health Declaration on Ministry of Civil Aviation's 'Air Suvidha' portal will no longer be required for international travellers coming from/via China, Singapore, Hong Kong, Republic of Korea, Thailand and Japan, from 13th Feb 2023, 11 a.m. However, the exercise of random testing of 2% travellers to India (irrespective of country of origin) upon arrival in India shall continue. Please Note: - *Children under 12 years of age are exempted from both pre-departure and post-arrival random testing. However, if found symptomatic for COVID-19 on arrival or during the period of self-monitoring, they shall undergo testing and treated as per laid down protocol. - All travellers arriving from international destinations and connecting to a domestic

destination must recheck-in their bags at the first port of entry, regardless of thorough check-in done till the final destination. - Some states may have different eligibility criteria for arrivals. Please check the detailed guidelines for your chosen destination before planning your travel.

- **Visa Requirements** : All travellers must present hard copies of their foreign visa (soft copies won't be accepted) at the immigration counters during departure.
